The Secretary may arrange call for an emergency meeting with the consent of the President or on the requisition of five members of the Executive Committee in writing.

The meeting of the Executive Committee will be presided over by the President and in the event of the President being not present or not being able to participate in the meeting; one of the Vice-President will preside.

No rule shall be passed, cancelled or modified except by a resolution supported by 3/5th of the Members in a General Meeting convened.
